### 1. BIDDER QUESTION

On sheet D3.2 of the "Pier 4 Phase 1 Removal Action Final Drawing Set" plan there is a callout for three timber fender piles between bent 143 and 144, row ss, and another one timber fender pile between bent 141 and 142, row kk. Those locations seem odd. Are those callouts correct?

#### RESPONSE TO BIDDER QUESTION

The callouts are correct. The timber piles were identified during the course of an under-dock inspection performed by KPFF.

### 2. BIDDER QUESTION

In section 02 41 00 "demolition", paragraph 1.03 A 1 f Reference Drawings, sheets 39 through 41 is referenced. However when opening file the sheet 41 is missing. Include are the sheets 39 followed by sheet 42. Please explain.

#### RESPONSE TO BIDDER QUESTION

Sheets 40 and 41 were located at the end of the plan set. They have now been moved to the correct location.

### 3. BIDDER QUESTION

In section 02 41 00 "demolition", paragraph 1.03 A 4 f Reference Drawings, sheets 61 through 6 is referenced. Please explain.

#### RESPONSE TO BIDDER QUESTION

This is an error and the sentence should read "sheets 61 through 69." This will be corrected via Addendum No. 01.

### 4. BIDDER QUESTION

Is there someone I can contact to look at the electrical system to price the two 600A temp power feeders required for the water treatment facility on the Pier 4 project as shown on sheet C2.2?

#### RESPONSE TO BIDDER QUESTION

The Port will accommodate this request and provide a second site visit to view the distribution panel board located within the transload area at APM Terminals. The site visit will commence in the Port Administration parking lot at 1 Sitcum Plaza on Thursday, February 26th at 11:45am.
