RFP ELEMENTS & EVALUATION CRITERIA:</p> <p>Proposals should present information in a straightforward and concise manner, while ensuring complete and detailed descriptions of the firm's/team's abilities to meet the requirement of this RFP. Emphasis will be on completeness of content. The written proposals should be prepared in the sequential order as outlined below.</p> <p>Proposals are limited to 40 numbered pages (8 ½ by 11 inch) including the cover letter and any submitted appendices, but excluding references and compensation information which are to be submitted separately. All pages shall be in portrait orientation</p>		<p>Proposals are limited to 40 numbered pages (8 ½ by 11 inch) including the cover letter and any submitted appendices, but excluding references and compensation information which are to be submitted separately. All pages shall be in portrait orientation with 1 inch margins. Font size shall be 11 point or larger. Proposals that do not follow this format will not be reviewed.</p>
